The University of Southern Mississippi anticipates purchasing the item(s) listed below as a sole source purchase. Anyone objecting to this purchase shall follow the procedures outlined below.

1. Description of the commodity that USM is seeking to procure:

The BLADE is a laboratory scale microwave heating system designed for small-scale reactions. It applies microwave energy to reactions under temperature and pressure feedback-controlled conditions to accelerate the reaction time. CEM Corporation is the sole provider of the CEM Corporation BLADE System.

2. Explanation of why the commodity is the only one that meets the needs of the agency:

We will be handling client samples at high volume and high sample mix. The BLADE allows us to process mixed sample types in one batch so we can run testing in a cost and time efficient manner.

3. Explanation of why the source is the only source is the only person or entity that can provide the required commodity:

CEM is the sole source of supply for an automated single mode cavity microwave digestion system with an autosampler to load and unload individual vessels into and out of the microwave cavity. The autosampler allows you to run multiple sample types in one batch. The BLADE is also the only system that incorporates a camera for real time digestion viewing.

4. Explanation of why the amount to be expended for the commodity is reasonable:

The cost is reasonable because of the labor that will be saved with the capability to run multiple types of samples in one run rather than multiple runs.

5. Efforts that the agency went through to obtain the best possible price for the commodity:

We met with multiple sales representatives and companies that gave us presentations on the microwave digestion systems offered. The BLADE by CEM is the only equipment that can handle high sample mix in one batch.
